3. Payment Terms

- Deposit: \$500–\$1,000 (refundable after inspection)
- Payment Due: Prior to pickup
- Late Fee: \$50/day
- All payments final — No refunds / No chargebacks
- Chargebacks = theft of services

4. Renter Requirements

1. Commercial use only
2. Valid driver license
3. 1-year experience preferred

4. Must provide required insurance

5. Must sign all forms

5. Pre-Rental Inspection

- Daily Inspection Log completed
- Photos/video required
- All prior damage documented

6. Renter Responsibilities

- Follow all laws
- No overloading (GVWR limits)
- No illegal freight
- Daily checks: oil, coolant, tire pressure
- No smoking
- Report incidents ASAP
- Return fuel level the same

7. Maintenance & Damage

- Routine maintenance included
- Renter pays for mechanical abuse
- Renter pays for tire damage
- Cleaning fee up to \$150
- Deposit may be withheld

7A. MAINTENANCE & MECHANICAL RESPONSIBILITIES

Owner Responsibilities:

- Routine oil changes
- Normal preventative maintenance
- Mechanical repairs not caused by misuse or negligence

Renter Responsibilities:

- Tire repair or replacement due to damage or blowouts
- Brake repairs caused by misuse or excessive wear

- All damage caused by accidents, negligence, or improper operation
- Returning the truck in the same mechanical condition as received
- Maintaining safe levels of all fluids (oil, coolant, DEF, brake fluid, etc.)
- Renter is responsible for paying any insurance deductible in full.
- Reporting ANY issues, warnings, lights, noises, or leaks immediately
- Bringing truck in for scheduled inspections and oil changes
- Not operating the truck with active warning lights

Critical Clause:

- **If the renter fails to report any warning lights, leaks, noises, overheating, or drivability issues immediately, the renter is fully responsible for all resulting damage, repairs, towing, downtime, and costs.**

8. Safety & Compliance

- Must follow Texas laws
- Must follow DOT/FMCSA rules
- GPS may be active
- Spot inspections allowed

9. No Unauthorized Drivers/Subleasing

- Only approved drivers can operate
- No subleasing or third-party renting

10. Travel Restrictions

- Texas-only
- No out-of-state
- Unauthorized travel → termination + deposit loss

11. GPS Tracking & Tampering

- Cannot disable GPS
- Tampering = termination + deposit loss + legal action

12. Recovery & Towing

- **Renter pays for:**

- Towing
- Recovery
- Retrieval
- Abandonment

13. Operating Area Disclosure

- Primary Area: _____
- Additional Stops: _____
- Max Daily Miles: _____

Unauthorized travel may result in termination, deposit loss, towing fees, and recovery charges.

14. Accident Procedure

- Report immediately
- Provide police report
- Provide photos
- Provide insurance info

15. No-Abandonment Clause

- Mechanical issues do NOT allow abandonment.

16. Abandonment Liability

- If abandoned:
- Deposit lost
- Renter pays towing, storage, damages

• 17. Repossession Authorization

- Redeye may repossess for:
- Non-payment
- GPS tampering
- Contract violations
- Insurance cancellation

18. Load Securement Responsibility

- Renter is 100% responsible for securement.

19. Cargo Liability Disclaimer

Redeye is NOT responsible for:

- Lost cargo
- Damaged cargo
- Stolen cargo
- Spoiled freight

20. Warranty of Truth

- Lying = immediate termination + deposit loss.

21. No Agency Relationship

- Renter is NOT an employee or agent of Redeye.

21A. Insurance Requirements (Mandatory for All Rentals)

The renter must provide valid commercial insurance meeting the following minimum requirements before pickup:

1. \$1,000,000 Commercial Auto Liability
2. Physical Damage Coverage (Comp & Collision) covering the rented truck
3. Cargo Coverage (if hauling freight)
4. ACORD Certificate of Insurance (COI) sent directly from renter's insurance provider
5. Red Eye Exclusive Trucking LLC must be listed as:
 - **Additional Insured**
 - **Loss Payee**
 - **Certificate Holder**

Insurance documents must be approved prior to rental.

Failure to maintain active insurance during the rental period will result in immediate termination, mandatory truck return within 2 hours, and possible repossession at renter's expense.

The renter is responsible for all deductibles, uncovered damage, and any claims denied by their insurance.

22. Indemnification Clause

- Renter agrees to defend & hold harmless Redeye Exclusive Trucking LLC from:
- Claims
- Lawsuits
- Damages
- Negligence
- Injuries
- Operational errors

23. Arbitration Agreement

- All disputes resolved through binding arbitration, not court.
